Residents Parking and Pedestrian Safety Plan Approved by the Parish

Council – The biggest change in the past three months has been the Council's approval of a Residents Parking and Pedestrian Safety Plan for the village High Street. This plan was developed by the Traffic and Parking Working Group (TAPWG) that was re-formed in 2021 following a rethink after COVID, working closely with Oxfordshire County Council (OCC) Highways team. As of November 2022, data from the Toll bridge shows that traffic levels are back to 80% of pre-COVID levels, with no sign of slowing down.

A new village-wide survey was conducted in September 2021, which was returned by 178 residents from 164 households. Whitchurch residents have been requesting Residents Parking on the High Street for many years and this was reinforced in the September 2021 survey response. SODC and OCC support for new Residents Parking schemes has only been available in the past year due to changes in policy and, if the scheme goes ahead, we will be amongst the first villages in the county to take advantage of it. There is an article that details the plan later in this issue of the Bulletin, and further information is available on the village website. The next step is for OCC to start the process to obtain the Traffic Regulation Order, which will allow them to begin a public consultation that everyone in the village will be able to participate in.

The Parish Council is acutely aware that historic and geographical constraints in the village mean that no parking plan can meet everyone's needs and any approach will require compromise. Many people in the village already compromise in terms of traffic and parking, whether it is lack of parking, accessibility of parking, or being a pedestrian or regular driver in the High Street. The approved plan will still require compromise, but it will have added benefits of providing parking bays dedicated for residents of the village, improved traffic flow, improved safety for both drivers and pedestrians, and reduced congestion and pollution in the village.

I would like to thank the seven members of TAPWG, including Cllrs Diana Smith and Frances Parkes for their hard work and methodical, transparent, data-driven analysis in coming up with this plan.

Grant for New Benches in the Playground – The Parish Council received a £2,500 grant from SODC to restore two benches on the Manor Road Playground. Cllr Higley is leading the work to restore the benches.

Playground Working Group to be formed – Cllrs Paul O'Grady and Carrie Leadbeater-Hart are planning to form a Playground Working Group to discuss changes to the playground following feedback from the recent survey. Please contact them if you would like to be involved.

Local flooding and drainage - Leigh Travers, SODC Flood Risk and Drainage Engineer, assisted by another SODC engineer, met John Southey and Richard Wingfield of the Flood Risk Team:

- SODC performed a topological assessment of the watercourse running under the High Street and Eastfield Lane. They will use this information to assess the feasibility of improvements to the watercourse to reduce the risk of flooding.
- The Walled Garden on the High Street –The SODC Engineer advised the
 owners that any changes to the pond and watercourse must be stopped
 and reinstated. Richard Wingfield and John Southey from our Flood Risk
 Team are satisfied that the current 'narrow channel' form of the pond
 should not impact flood risk, as long as it stays a viable channel for the
 village watercourse.
- Greyhound slotted drain cover has now finally been delivered and installed. This was paid for by the Greyhound owners, Oak Taverns. The slotted cover allows overflow water to be drained down the watercourse under Eastfield lane in the event that the High Street drains become overwhelmed during a flash flood.

Re-establishment of Manor Road Yew Trees – A reminder that the Parish Council had previously approved plans last year to re-establish the historic row of yew trees on the south side of Manor Road that formed the entrance to Coombe Park. This change is now happening in January. The removal of approximately 18 mostly sycamore trees and laurel undergrowth, will cause a significant change to the entrance to Manor Road until the row of young yew trees is better established. Thanks to Cllr Katherine Higley for leading this work.

Fibre Broadband to the Door in the Village - Things are progressing here, although I am not aware of anyone getting fibre broadband as we speak. Airband has been talking to residents at the doorstep to firm up plans for offering fibre to the home - at least on Hardwick Road. Gigaclear has offered to meet me to explain their plans for providing fibre to the village. I am still waiting for them to confirm a date for the meeting. We have also been notified that the Village Hall is eligible for funding to provide fibre connectivity.

PC APPROVES RESIDENTS PARKING AND PEDESTRIAN SAFETY PLAN FOR THE HIGH STREET

The Parish Council passed a motion to proceed with a Residents Parking and Pedestrian Safety plan for the village at its November meeting. The Traffic and Parking Working Group (TAPWG), working in consultation with the Oxfordshire County Council (OCC) Highways Department, developed the recommended scheme based on the findings from the village-wide survey carried out in September 2021. The key objectives of the recommendations were to provide dedicated parking spots on the High Street for residents of the village and to ensure that there is clear visibility for pedestrians crossing the High Street near the Greyhound, especially for parents and children on the school run. The plan would have additional benefits in terms of improved traffic flow, improved safety for both drivers and pedestrians, and reduced congestion and pollution in the village.

A detailed map of the parking plan for the High Street is available on the village website. Although not on the map, a "virtual pedestrian crossing" will be created with improved visibility, from the movement of certain parking bays, with designated crossing locations on either side of the street just north of Eastfield Lane across from the Greyhound.

OCC's Parking and Traffic Officer attended the November meeting and answered questions from Councillors. Some of the questions answered in the discussion were:

- The plan included 4 banks of parking bays on the High Street with a total of 19 residents parking spaces. The OCC Officer confirmed that this was the maximum number of spaces that could be approved for the parking plan due to sight lines of traffic. There are currently a large number of parking spaces used by non-resident commuters during the day that would be freed up for residents in the plan. At the January PC meeting, the Council agreed that 3 of these parking banks should be dedicated to Residents Only parking, although one of the banks of 7 parking bays should be available to people who do not have a permit for up to 2 hours.
- Residents on the High Street will be able to purchase annual parking permits
 for about £100. Residents can purchase permits for up to 2 cars per
 household. 25 visitor passes will be included in the permit fee. Additional
 visitor passes can be purchased by residents of the High Street, whether
 they have an annual permit or not.

- An amendment to the plan was approved that made use of single yellow lines in some locations south of Manor Road that would allow for approximately 10 additional car parking spaces for those without parking permits to use outside the restricted hours. At the January PC meeting, the Council agreed that single yellow line no parking restrictions should be only for Monday to Friday 8am – 5pm. Parking will be allowed along the single yellow lines at all other times, including weekends.
- There will be single or double yellow lines between each of the 4 banks of parking bays. OCC requires double lines between the upper and lower narrows and the first bank of parking bays to keep traffic clear. The OCC Officer was clear that the Residents Parking scheme could only be approved if yellow lines were implemented on the High Street to ensure it can be enforced. The plan is to use Heritage Area versions of the lines, which would be thinner and paler.
- The "virtual pedestrian crossing" to be placed just north of Eastfield Lane across from the Greyhound is proposed instead of a Zebra crossing because of costs and to avoid the use of Belisha beacons (amber coloured globe lamps on top of a black and white striped pole) which could be a source of light pollution to nearby residents. Although there will be no road markings, it will make use of a dropped kerb and designated crossing locations on either side of the road, with 20 metres visibility in either direction, which is a significant improvement over the current situation. The virtual crossing will run from the dropped kerb on the west side of the High Street to a newly surfaced area on the east side which will be marked by white lines guiding pedestrians safely into Eastfield Lane.

The next steps:

- OCC will start the process to obtain the Traffic Regulation Order, which will allow them to begin a public consultation. We understand that consultation letters will be sent to all properties in the High Street and notices will be put in local newspapers, on lampposts and on the OCC website. This is a similar process to that which happened before the 20mph limit was agreed.
- After the consultation, OCC will make the final decision on whether to proceed with the changes, including any alterations resulting from the consultation. OCC says that the timeframe for consultation and implementation can be anywhere from 6 months to 2 years.
- If the changes are agreed and implemented there would be a review by OCC after it has run for a year. We are told that it is possible to make changes to the scheme at this time should they be necessary.

DISTRICT COUNCILLOR'S COMMENTS

Money Money Money

One of the less enjoyable days of the year is when the annual Council Tax bill lands on the doormat, and one gasps at the amount of money being demanded. Although the bill comes from the District Council (SODC), council tax is largely being collected on behalf of the local big spenders, i.e. the County Council and the Police who take 78% and 11% respectively. The District Council keeps only 6% and the parishes about 5%. The District Council also collects Business Rates, technically called Non Domestic Rates, or NDR. During the pandemic businesses that were liable for Business Rates were entitled to grants of various sorts, funded by the government but distributed by South Oxfordshire District Council. This was quite a big exercise for the Council, dishing out money instead of collecting it, and the District Council was pleased to support all sorts of eligible businesses. However, in the general rush to take advantage of the sudden fruiting of the magic money tree, some businesses which applied for this largesse forgot that they actually didn't pay business rates. On investigation, some of these businesses should have been paying quite substantial amounts.

Elected council members of the Green Party and Lib Dem administration of SODC suspected that there may have been more businesses liable for business rates which were not being collected. External consultants were therefore employed to match data from different sources to make sure that businesses in South Oxfordshire were paying their taxes like the rest of us. Amazingly, this exercise netted £2.6 million pounds of back tax, of which £500,000 has been retained by SODC and there will be an extra £200,000 a year coming to the District Council in future. The current administration at South Oxfordshire is keen to make sure that it is financially secure, and collects all the income that is legally due, and these additional funds are a welcome contribution to the budget; the backlog of £500,000 is equivalent to about 6% of the District's funding from Council tax.

This was an initiative by elected Councillors who know that the devil is in the detail, and who work hard for the benefit of residents.

Aircraft Noise

Over the years, several people have raised concerns with me about the noisy planes that buzz around for about 10 minutes or so looping the loop, vertically diving etc., before pulling up. Being so high, the noise from these planes is audible over a wide area, but strangely there is not much legal constraint over this noise. All planes carry a registration number, but even with powerful binoculars the number can't be seen from the ground. There is a however a website https://www.flightradar24.com/51.29,-1.45/11 that tracks every plane in the sky, and with this you can identify any plane that's flying near you, whether is a passenger airline, executive jet, helicopter or light aircraft, where it has come from and then where it is going. Click on a plane, and you can see its flight path and its registration number, and from the registration number track the owner.

If you wish to complain about the noise of an aircraft, the Civil Aviation Authority states: "In general, if you have a complaint about aircraft noise, you should direct to it the airport where you think the aircraft was operating from. They have a duty to investigate your complaint and respond to you."

The flight radar website shows where the plane has come from, which when I have tracked noisy aircraft, was White Waltham Airfield.
